Internet Policy

(Wired and Wi-fi Networks Policy)

GNDEC, Ludhiana (the "Institute"), provides wireless as well as wired internet access to the Internet for the entire campus to further enhance the academic mission of the institute and must be used in accordance with the responsibilities stated.

Access is intended for

- Faculty
- Staff
- Students
- Guests

Access is password protected. When using the network the user must use the credentials provided. These login details are unique to each user. Passwords should be kept confidential and not made available to anyone else. In order to connect to the wireless network, devices must have a Wi-fi compatible network card installed. The wireless card should detect the signal immediately. Because some wireless card software may require some additional procedures and/ or setting changes, users should consult the device user's manual, or contact the hardware or software provider for additional assistance.

The Internet is a public network and the {Institute} has no control over any of the Internet service providers, information service providers, network providers, content providers or such other similar or equivalent systems and services.
